The terms of reference of the aforesaid Committee shall be as under:-

1. To study the present scenario of the paramedical trainings both in the Government and Private sector in the State with reference to procedure for admissions, duration of trainings, syllabus, conduct of examinations, quality of infrastructure at different levels and for different categories in various paramedical institutes (both Government and Private sector) in the State.
2. To suggest and recommend measures for regulating and institutionalizing arrangements governing admissions, preparation of a common syllabus, duration of trainings in accordance with industry norms/standards, basic standards required to be maintained in regard to the quality of infrastructure at different levels and for different categories, and also the system of examinations broadly on the pattern of the Technical Education Department, where the job is entrusted to the State Board of Technical Education (SBOTE).

3. Any other issue(s) related thereto as may come to the notice of the Committee in the course of its deliberations.

The Committee shall be free to co-opt any other officer/expert from within or outside the State, as may be required in its deliberations.

The Committee shall submit its report along with recommendations within a period of six months from the date of issue of this order.

The Committee shall be serviced by the Health and Medical Education Department.


