As per the approval of Worthy District Development Commissioner (Chairman District Health Society) Poonch, sanctioned is hereby accorded to the temporary appointment of the candidates against the posts of Assistant Surgeon as indicated in Annexure "A", Staff Nurse in Annexure "B", Computer Assistant under ARSH in Annexure "C" and Dawasaz in Annexure "D" to this order for the implementation of National Rural Health Mission in District Poonch. The appointment shall be subject to the following terms and conditions.

1. The appointee shall be purely on contractual basis with a monthly consolidated remuneration;
2. The appointee shall be purely on contractual basis for a period of one year and shall be extendable depending upon the term of the Mission to be approved by GOI to satisfactory performance of the contractual appointee. In case of unsatisfactory performance, the Chairman shall have the right to terminate the services of the contractual appointee without any notice;
3. The contractual appointee shall have to execute an agreement with District Health Society on the prescribed format;
4. This contractual appointment shall not confer any right on the appointee to claim for regular selection against these posts or any preferential right during any selection process;
5. The appointee shall be entitled to the remuneration only after attending their places of postings regularly during the time of the contractual appointments;
6. No TA/DA shall be admissible to the appointee at the time of joining nor during the time of contractual appointment subsists;
7. Contractual appointee shall not be transferable from one place of posting to other;
8. If the contractual appointee at any time willfully neglects or refuses to perform his/her duties, his/her services shall be immediately terminated without any notice and he/she shall not be entitled to any salary for such period;
9. The contractual appointee shall not be entitled to any monetary benefits or any other allowances whatsoever;
10. The contractual appointee shall be entitled to casual leave as admissible;

The appointees mentioned in Annexure “ A” ,”B”, “C” and “D” shall report the Office of Chief Medical Officer (Vice Chairman District Health Society) Poonch for further adjustments within ten days failing which their appointment shall be treated as cancelled.
